

ISS A/S - STATUTORY REPORT ON CORPORATE GOVERNANCE

This report on corporate governance for ISS A/S ("ISS" or the "Company") has been prepared in connection with the Company's admission of its shares to trading and official listing (the "Listing") on NASDAQ OMX Copenhagen A/S ("NASDAQ OMX Copenhagen") and will be effective as from the date of the Listing. The report includes a description of the Company's governance structure and an overview of the Company's position on the Danish Recommendations on Corporate Governance issued by the Danish Committee on Corporate Governance in May 2013. ISS' GOVERNANCE STRUCTURE

ISS has a two-tier governance structure consisting of:

- the Board of Directors, and
- the Executive Group Management Board.

The Board of Directors determines the overall Group strategy and supervises the Company's activities, management and organisation. The primary tasks of the Executive Group Management Board are to carry out the day-to-day management of the ISS Group. No person serves as a member of both of these bodies.

Board of Directors

Currently, the Board of Directors has seven members elected by the general meeting for a term of one year. The Board of Directors has elected the Chairman and the Deputy Chairman among its members. Board members are eligible for re-election. Only persons who are younger than 70 years at the time of election may be elected to the Board of Directors. Currently, four of the members, including the Chairman, are considered independent, while three members represent the interests of the Company's controlling shareholder due to their affiliation with certain funds advised by EQT Partners ("EQT") and funds advised by affiliates of Goldman Sachs Group, Inc. ("Goldman Sachs Capital Partners") and Ontario Teachers' Pension Plan Board ("OTPP"), respectively, and are therefore not considered independent. Following the Listing, the current representative of OTPP, Jo Taylor, would be considered independent. In addition to the Board members elected by the general meeting, three employee representatives serve on the Board of Directors. They have been elected on the basis of a voluntary arrangement regarding group representation for employees of ISS World Services A/S as further described in the Articles of Association. Employee representatives serve for terms of four years.

The Board of Directors convenes at least six times per year, including for one strategy meeting each year.

The Board of Directors evaluates its performance on an annual basis and will evaluate (i) the work of the Board of Directors, (ii) the performance of the individual members of the Board of Directors and (iii) the collaboration between the Executive Group Management Board and the Board of Directors.

Board committees

The Board of Directors has established an Audit and Risk Committee, a Remuneration Committee, a Nomination Committee and a Transaction Committee. Each committee has a charter, which sets out purpose, assignments and procedural matters. The committees report to the Board of Directors. The majority of the mem-



bers of the Audit and Risk Committee, the Remuneration Committee and the Nomination Committee will upon completion of the Listing be considered independent, and half of the members of the Transaction Committee will be considered independent.

Audit and Risk Committee

The Audit and Risk Committee evaluates external financial reporting, the main accounting policies and estimates and assesses systems of internal controls and risk management. Its duties also include supervision of the external auditor and the group internal audit function in addition to considering the relationship with the external auditors.

Remuneration Committee

The Remuneration Committee assists the Board of Directors in its preparation of the Remuneration Policy and the Overall Guidelines on Incentive Pay and recommends to the Board of Directors the remuneration of the members of the Board of Directors and the Executive Group Management Board as well as a general remuneration policy for the Company.

Nomination Committee

The Nomination Committee assists the Board of Directors with ensuring that appropriate plans and processes are in place for nomination or appointment of candidates to the Board of Directors and the Executive Group Management Board and evaluating the composition of these boards.

Transaction Committee

The Transaction Committee makes recommendations to the Board of Directors in respect of certain large acquisitions, divestments and customer contracts, reviews the transaction pipeline, considers our procedures for large transactions, and evaluates selected effected transactions.

Executive Group Management Board

The Board of Directors has appointed an Executive Group Management Board consisting of four members. The primary tasks of the Executive Group Management Board are to carry out the day-to-day management of the ISS Group, develop and implement strategic initiatives, develop Group policies, monitor Group performance and evaluate investments as well as acquisitions, divestments and large customer contracts.

RECOMMENDATIONS ON CORPORATE GOVERNANCE IN DENMARK

ISS is subject to the Danish Recommendations on Corporate Governance from May 2013, which are available on the Danish Committee on Corporate Governance's website, www.corporategovernance.dk. As a company listed on NASDAQ OMX Copenhagen in Denmark, ISS is required to report on its compliance with these recommendations according to the "comply or explain" principle. ISS' position on each recommendation is described below in this report. This report is not covered by the auditors' report in the annual report.

It is important for our Board of Directors to comply with good corporate governance practice, including statutory requirements and the Corporate Governance Recommendations. Accordingly, our Board of Directors regularly reviews its rules of procedure, charters, policies and practices. NASDAQ OMX Copenhagen has incorporated the Corporate Governance Recommendations in its Rules for issuers of shares, and we intend to comply with the Corporate Governance Recommendations in all material respects, with three exceptions:



Firstly, following the Listing, half of the members of the Transaction Committee will be considered independent. The reason for the composition of the Transaction Committee is due to the expected ownership structure after the Listing where EQT and Goldman Sachs Capital Partners will continue to hold a significant stake in the Company.

Secondly, the Company's transition share programme ("TSP") is established to ensure a possibility of share-related instruments vesting in the first two-year period after completion of the Listing. Accordingly, the performance based share units ("PSUs") granted under the Company's TSP vest, subject to achievement of certain bonus objectives, earlier than three years from the date of the grant.

Thirdly, the Company's short term incentive programme ("STIP") is a cash based bonus with a deferral element to link a portion of the paid cash bonus to the price of the Company's shares as 1/3 of any cash bonus payable (net of taxes) is settled in RSUs when the cash bonus is paid. The RSUs are converted into shares on the first and second anniversary following the payment of the cash bonus with 50% each time. 50% of the RSUs received under our STIP can be converted into shares earlier than three years from the date of the grant of the bonus.

Reference is also made to recommendations 3.4.2 and 4.1.4, respectively, in the report below.

The composition of the Board of Directors and the Executive Group Management Board, respectively, is diverse in many aspects. The Board of Directors considers that the Executive Group Management Board meets the target for international experience. Once a year, the Board of Directors will discuss the Company's activities to ensure relevant diversity at management levels, including by reviewing the principles regarding competencies and diversity of members of the Board of Directors and the Executive Group Management Board. Presently, ISS A/S has no employees. ISS World Services A/S, which is a direct subsidiary of ISS A/S, employs the ISS Group's head office employees and ISS World Services A/S has adopted a Diversity Policy, which includes a gender diversity policy pursuant to the Danish rules regarding the underrepresented gender. Reporting in respect of cultivating gender diversity according to the Danish rules on the underrepresented gender will be carried out by the relevant legal entities in the ISS Group, including ISS A/S with respect to members of the Board of Directors.
